Warning against Bribery

1. The tenderer shall not and shall ensure that his agents and employees shall not give or offer any advantages to any agent or employee of The Kendo Association of Hong Kong, China (the “HKKA”), as defined under the Prevention of Bribery Ordinance. The tenderer is also prohibited from colluding with other bidders in this tendering exercise in whatever forms (e.g. price rigging). Any breach of or non-compliance with these clauses by the tenderer shall, without affecting the tenderer’s liability for such breach or non-compliance, invalidate his tender.
2. If the supplier/contractor or any employee or agent of the supplier/contractor shall be found to have committed an offence under the Prevention of Bribery Ordinance in relation to the tender or the contract, the HKKA may terminate the contract without entitling the supplier/contractor to any compensation therefore, and the supplier/contractor shall be liable for all losses and expenses necessarily incurred by the HKKA as the result of such termination of the contract.

Submission of Tenders

3. Tenderers must submit their tenders before the tender closing date and time specified in the tender documents. Any tenders received after the tender closing time shall not be considered. In the event of Typhoon Signal No. 8 or above, or Black Rainstorm Warning is hoisted on the tender closing date, the closing time will be automatically postponed to 12:00 noon of the next working day.
4. Tenders should be placed in a sealed envelope and deposited in HKKA mail box: Rm 1029, Olympic House, No. 1 Stadium Path, So Kon Po, Causeway Bay, Hong Kong
5. The awarded tender will be notified by telephone and email within 20 working days and be invited to enter into a contract with the HKKA.
6. HKKA is not bound to accept any proposal it may receive.
7. It should be noted that HKKA will not be responsible for the reimbursement of any cost incurred by you for the preparation of the submission of tender.

Background Information

The Kendo Association of Hong Kong, China (“HKKA”) is going to organise the 22nd Hong Kong Asian Open Kendo Championships at To Kwa Wan Sport Centre, it is expected to have around 350 participants. We would like to invite tender for hotel accommodation.

Tender Selection Criteria

The selection of the winning proposal will be based on the respective applicants' scores out of 100 for the following areas:

Criteria	Percentage
Price	50%
Proximity to Venue	20%
Hotel Facilities	15%
Convenience of Accommodation	15%

The criteria that will be used to assess the Price will be as follows:

- a) Room rate
- b) Room upgrade
- c) Any additional offers (i.e. offer complimentary or discounted costs for breakfast)

The criteria that will be used to assess the Proximity to Venue will be as follows:

- a) Distance of hotel from the event venue

The criteria that will be used to assess the Hotel Facilities will be as follows:

- a) Quality of hotel facilities, including gym, hotel room, etc

The criteria that will be used to assess the Convenience of Accommodation will be as follows:

- a) Time taken for travelling between hotel and To Kwa Wan Sports Centre
- b) Convenience to major MTR/bus stations
